**All 2-dimensional artwork must have proper hanging wire attached in order to be considered.**

**Artists are encouraged to attach an artist statement describing the artist's vision, technique, or any other pertinent information that might be included with artwork when on display.**

### ENTRY REQUIREMENTS

Open to visual artists working in 2D and 3D media. Artists must be at least 18 years of age. Application must include digital images of each entry by email to [galleriatthecenter@gmail.com](mailto:galleriatthecenter@gmail.com) or on compact disc, or color copies on 8½"x11" paper. By submitting, Applicant gives permission to Phoenix Center for the Arts, Inc. (PCA) to use images of any accepted works for promotional purposes. **\$30 application fee per show, check or money order, payable to: Phoenix Center for the Arts.** Application fees are non-refundable, regardless of acceptance. **PCA charges a 30% commission on all gallery sales.** If accepted, artwork must be received no later than seven calendar days prior to opening, either by hand-delivery or by mail. PCA is not responsible for any damage occurring to artwork in shipping, both in transit to PCA or when being returned to artist. Artists are responsible for all return shipping costs, and must arrange for return shipment of artwork. Phoenix Center for the Arts is not responsible for artwork left more than 7 days after closing date of show, unless previously arranged in writing. Phoenix Center for the Arts houses the Gallery in a secure building with staff present throughout the day, however PCA is not liable for any damage or theft that may occur to any person or property. Artist may insure their own artwork, as desired.
